The Florida Department of Transportation (FDOT), District Seven, is hosting a Construction Open House on July 27, 2023, for the Interstate 75 (I-75) Ramp Reconfiguration and Interchange Modification from State Route (S.R.) 574 (Dr. Martin Luther King Jr. Boulevard) to Interstate 4 (I-4) in Hillsborough County, Florida.

This project is building a barrier separating northbound I-75 mainline travel lanes from traffic entering and exiting the interstate from Dr. Martin Luther King Jr. Boulevard and the I-4 exits. A two-lane northbound collector-distributor (CD) roadway is being built east of the current northbound travel lanes within the existing right of way. Traffic entering and exiting northbound I-75 at Dr. Martin Luther King Jr. Boulevard and I-4 will use the new CD roadway. In addition to the improvements on I-75, the Dr. Martin Luther King Jr. Boulevard interchange is being converted to a diverging diamond interchange.

The Department is offering multiple ways for the community to participate in the meeting. All participants, regardless of which platform they choose, will have access to the same materials provided on each platform.
