Purpose: The Florida Department of Transportation (FDOT), District Seven, invites you to attend and participate in a Public Meeting covering the proposed improvements to the intersection at CR 52 and College Avenue/Pompanac Street in San Antonio, Pasco County, Florida. The Public Meeting will be held on July 12, 2023, at 5:30 p.m.

This project will improve the intersection at CR 52 and College Avenue/Pompanac Street by constructing a Roundabout. Improvements will include multimodal features such as sidewalk and bicycle facilities, driveway modifications, drainage, and signing and pavement markings.

To allow for maximum participation, the public meeting will be held in two formats including online and at an in-person drive-thru location. The information presented will be identical at all options.
